This award is open for new franchise system registered as a FRANCHISOR under Section 6, Franchise Act 1998 (Amendment 2012). Franchise business has been in operation for at least 1 year and less than 4 years. One (1) winner will be awarded under this category

MASTER FRANCHISEE OF THE YEAR

This award is open for franchise system registered as a MASTER FRANCHISEE under Section 6A, Franchise Act 1998 (Amendment 2012). Franchise business has been in operation for at least 4 years. Three (3) winners will be awarded under this category.

FRANCHISOR MICRO & AFFORDABLE OF THE YEAR

This award is open for franchise system registered as a FRANCHISOR under Section 6A, Franchise Act 1998 (Amendment 2012). Franchise business has been in operation for at least 1 years. Franchise Package offered less than RM100,000

INTERNATIONAL FRANCHISOR CATEGORY



FRANCHISOR OF THE YEAR

- This award is open for homegrown franchise system registered as a FRANCHISOR under Section 6, Franchise Act 1998 (Amendment 2012). Franchise business has been in operation for at least 4 years.
- This award offered especially for homegrown franchisor that shows tremendous performance on in EXPANDING their business internationally.
- Asia Pacific, Middle East & Europe. Three (3) winners will be awarded under this category

FRANCHISEE CATEGORY



Franchisee Of The Year

This award is open for franchisee registered with homegrown system only. Franchise business has been in operation for at least 4 years.

Emerging Franchisee Of The Year

This award is open for franchisee registered with homegrown franchise system only. Franchise business has been in operation for at least 1 year and less than 4 years and it is the first outlet.

International Franchisee Of The Year

■ This award is open to the Franchisee to Foreign Franchise Brand. Franchise business has been in operation for at least 4 years.

Emerging International Franchisee of The Year

This award is open for franchisee to Foreign Franchise Brand. Franchise business has been in operation for at least 1 year and less than 4 years and it is the first outlet.

Franchisee Micro & Affordable Of The Year

■ This award is open for franchisee to homegrown system only. Franchise business has been in operation for at least 1 year and it is the first outlet. Franchise Package signed less than RM100,000.

OPEN CATEGORY



BEST CSR FRANCHISE ECOSYSTEM

- This category open to all Valid MFA members. CSR activities may include but not limited to education, environment, culture and heritage, community and social welfare, empowerment of women and opportunities for people with disabilities.
- Develop organization/company in relation to CSR or contribution to the community and environment for sustainability. Spread the organization's/company's policy to employees and external parties and involves them in achieving the goals.

BEST EMPLOYER FRANCHISE ECOSYSTEM

This category open to all Valid MFA members. Franchise business has been in operation for at least 3 years, with audited accounts for year 2019, 2020 and 2021. The award winner in 2020 and 2021 is not qualified to submit the nomination form

BEST INNOVATION FRANCHISE ECOSYSTEM

■ This category open to all Valid MFA members. The innovation that will be contested may include product innovation or service innovation or a combination of which have been implemented in Malaysia only. The innovation must be implemented in business operations in 2021.

OPEN CATEGORY



BEST ESG EFFORT FRANCHISE ECOSYSTEM

- This category open to all Valid MFA members. Each criterion of ESG plays an important role in the effort to increase focus on sustainable and ethical investments.
- Environmental factors involve how much an organization considers the protection of natural resources such as Air and water quality, Biodiversity, Energy performance & Waste management and pollution.
- Social factors address how an organization treats people around like Community relations, Customer satisfaction,
 Data protection and privacy policies and efforts and Employee diversity, equity and inclusion.
- Governance examines how a corporation polices itself, focusing on internal system controls and practices to maintain compliance. Governance also focuses on transparency, industry best practices, organization management and associated growth initiatives
